## **THE SON-IN-LAW OF A FREEMAN**

### **ESSENTIAL DOCUMENTS TO BE SUBMITTED SUPPORTING THE APPLICATION FOR THE FREEMEN'S ROLL**

In order to qualify for admission to the Freeman's Roll, the following documents should be submitted to Llantrisant Town Trust, together with the Form of Claim no later than the 1<sup>st</sup> April of the year in which the annual Court Leet is held.

- a. Applicant's Birth certificate [or photocopy].
- b. Applicant's Marriage certificate [or photocopy].
- c. Birth certificate [or photocopy] of applicant's wife **showing the names of the parents.** No other form of certificate is acceptable. Copies are available from your Registry Office if required.
- d. Enrolment fee of £100.00 to be made payable to Llantrisant Town Trust. This is inclusive of the purchase price of the Freeman's tie.
- e. A photograph of each applicant for the Freeman's Roll is required. This can be submitted with this application or via email to the Trust.

## **ATTENDANCE AT THE COURT LEET**

All applicants are expected to attend in person at the Court Leet, and to be accompanied by a relative or sponsor, so that he may be formally presented and his identity confirmed.

Valid reasons for failure to attend the Court Leet shall be given in advance and applicants may be enrolled in absentia.

Trustees may, at their discretion, require the attendance of all applicants at the Court Leet.
